



PRIVACY INFORMATION

The Pizzi Cannella archives, according to art. 13 D.lgs 30/06/03, n. 196 (regarding the field of protection of personal data), informs that:

- the conferment of the data is facultative;

- in case of refusal, the Archives shall not see to the archiving, to the certifying and to the cataloguing;

- the finality of the treatment is the cataloguing and the archiving of Piero Pizzi Cannella's work, the publishing of the General Catalogue and, in any case, in Italy and abroad, the knowledge, the promotion as well as the safeguard of Piero Pizzi Cannella's work;

- the data is archived in a computerized and paper way, at the office of the Archivi & Company s.r.l. society, located in Rome, in n. 3 Giuseppe Arimondi Street, 00159 Rome, tel 0645555241, fax 0645555261, www.archiviopizzicannella.it, e-mail: info@archiviopizzicannella.it; the society guarantees the minimum security measures in order to exclude loses and illicit uses.

In accordance with art. 7 of the Privacy Code

1) The person interested has the right to obtain the confirmation of the existence or non existence of personal data which regards him/her, even if it is not registered yet, and their communication in an intelligible form.

2) The interested person has the right to obtain the indication:

a) of the origin of the personal data;

b) of the finality and the modality of the treatment;

c) of the logic applied in the case of treatment carried out with the aid of electronic instruments;

d) of the essential identification elements of the titular, of the responsible individuals and of the designated representative in accordance with art. 5, comma 2;

e) of the subjects or of the category of subjects to which the personal data can be communicated or that come to know about in one's capacity as designated representative in the territory of the State, of the ones responsible or in charge.

3) The interested person has the right to obtain:

a) the updating, the rectification that is, when it regards him/her, the integration of the data;

b) the cancellation, the transformation in an anonymous form or the blocking of the data treated in violation of the law, including those of which the preservation is not necessary with reference to the purposes for which that data was gathered or successively treated;

c) the attestation that the operations to which the letters a) and b) refer were brought to the knowledge, even with regards to their content, of those to which the data has been communicated or diffused, with the exception of the case in which such a fulfillment reveals itself as being impossible or implies a use of means manifestly out of proportion compared to the safeguarded right.

4) The person interested has the right to oppose himself/herself, in all or in part:

a) for legitimate reasons to the treatment of personal data that regards him/her, if pertinent to the purpose of the collection;

b) to the treatment of personal data that regard him/ her with the aim of sending advertising material or that of direct sale or for the fulfillment of market research or of commercial communication.

Having read the preceding information, the undersigned(write in block letters) expresses, in accordance with art. 23 of the Privacy Code, the consent for the treatment.
